Downloaded files to a compact disc	\$1.00	\$1.00 per disk for downloading computer files to a compact disk.
Video tapes, cassette tapes, or for any other type of media	The fee shall be the replacement cost or the reproduction (copying) cost. Reproduction costs may only be charged if a commercial or professional service is contracted to provide the copy.	
Mailed records	Requestors will be charged in advance for the cost of postage if the copy is transmitted by United States mail or the cost of delivery if the copy is transmitted other than by United States mail, and to pay in advance the costs incurred for other supplies used in the mailing, delivery, or transmission.
