Executive Summary

This executive summary provides an overview of health-related data for Perry County adults (19 years of age and older) who participated in a county-wide health assessment survey from December 2020 through May 2021. The findings are based on self-administered surveys using a structured questionnaire. The questions were modeled after the survey instruments used by the Centers for Disease Control and Prevention (CDC) for their national and state Behavioral Risk Factor Surveillance System (BRFSS). The Hospital Council of Northwest Ohio assisted with survey development, guided the health assessment process, and integrated sources of primary and secondary data into the final report. Ohio University sought Institutional Review Board (IRB) approval for the project, administered the surveys, and collected the data.

Public Health Accreditation Board (PHAB)

National Public Health Accreditation status through the Public Health Accreditation Board (PHAB) requires Community Health Assessments (CHAs) to be completed at least every five years. The purpose of the community health assessment is to learn about the community: the health of the population, identify areas for health improvement, identify contributing factors that impact health outcomes, and identify community assets and resources that can be mobilized to improve population health.

PHAB standards highly recommend that national models of methodology are utilized in compiling CHAs. The 2021 CHA was completed using the National Association of County and City Health Officials (NACCHO) Mobilizing Action through Partnerships and Planning (MAPP) process. MAPP is a community-driven planning process for improving community health. This process was facilitated by HCNO in collaboration with various local agencies representing a variety of sectors.

This assessment includes a variety of data and information from various sources, focusing on primary data at the county level. Supporting data, such as secondary data, demographics, health disparities (including age, gender, and income-based disparities), and social determinants of health, can be found throughout the report. For a more detailed approach on primary data collection methods, please see the next section.

Primary Data Collection Methods

DESIGN

This community health assessment was cross-sectional in nature and included a written survey of adults within Perry County. From the beginning, community leaders and members were actively engaged in the planning process and helped define the content, scope, and sequence of the study. Active engagement of community members throughout the planning process is regarded as an important step in completing a valid needs assessment.

INSTRUMENT DEVELOPMENT

One adult survey instrument was designed for this study. As a first step in the design process, health education researchers from The University of Toledo and staff members from The Hospital Council of Northwest Ohio (HCNO) met to discuss potential sources of valid and reliable survey items that would be appropriate to assess the health status and health needs of adults. The investigators decided to derive the majority of the adult survey items from the BRFSS. This decision was based on being able to compare local data with state and national data.

The project coordinator from The Hospital Council of Northwest Ohio conducted a meeting with the Southeast Ohio Health Improvement Collaborative. During this meeting, HCNO and the Southeast Ohio Health Improvement Collaborative reviewed and discussed banks of potential survey questions from the BRFSS. Based on input from the Southeast Ohio Health Improvement Collaborative, the project coordinator composed a draft survey containing 110 items for the adult survey. IRB approval was granted to Ohio University by their universities Social and Behavioral IRB.

SAMPLING | Adult Survey

The sampling frame for the adult survey consisted of adults ages 19 and older living in Perry County. There were an estimated 26,099 people ages 19 and older living in Perry County. The investigators conducted a power analysis to determine what sample size was needed to ensure a 95% confidence level with a corresponding margin of error of 6% (i.e., we can be 95% sure that the "true" population responses are within a 6% margin of error of the survey findings). A sample size of at least 264 adults was needed to ensure this level of confidence for the general population.

The random sample of mailing addresses of adults from Perry County was obtained from Melissa Data Corporation in Rancho Santa Margarita, California. Surveys were mailed in early April 2021 and returned through mid-May 2021.

PROCEDURE | Adult Survey

Prior to mailing the survey, Ohio University mailed an advance letter to 2,000 adults in Perry County. This advance letter was printed on Southeast Ohio Health Improvement Collaborative stationery and signed on behalf of the group by the co-chairs Linda Supplee of Genesis HealthCare System and Angela DeRolph of the Perry County Health Department. The letter introduced the county health assessment project and informed readers that they may be randomly selected to receive the survey. The letter also explained that the respondents' confidentiality would be protected, and it encouraged the readers to complete and return the survey promptly if they were selected. Letters returned as undeliverable were not replaced with another potential respondent to receive the survey. Lastly, it is important to note that the advance wave letter stated that if the recipient was selected to receive the survey, they would receive a \$2 bill as a thank you for their time to complete the survey. After sending the letter, Ohio University encountered problems with this recruitment strategy due to institutional rules about exchanging money. A gift card drawing replaced the \$2 bill incentive that was originally noted. The letter included additional information regarding the drawing with information on how to enter by filling out a postage-paid card that was included in the mailing. Individuals receiving the survey and post card were asked to provide either their phone number or email address and instructed to mail the postage paid, post card separately from their survey.

Thirteen weeks following the advance letter, an additional mailing was administered. The mailing included a personalized, hand signed cover letter (on Southeast Ohio Health Improvement Collaborative stationery) describing the purpose of the study and the chances of winning a gift card, the questionnaire, a self-addressed stamped return envelope, and a postcard to enter the drawing for a \$100 or \$25 gift card. The mailing materials were included in a large colored envelope. A total of 3,000 surveys were sent out by Ohio University. Surveys returned as undeliverable were not replaced with another potential respondent.

The response rate for the adult population was 6% (n=180: $Cl=\pm 7.28$).

Note: "n" refers to the total sample size, "CI" refers to the confidence internal.

DATA ANALYSIS

Individual responses were anonymous. Only group data was available. All data was analyzed by health education researchers at the University of Toledo using Statistical Product and Service Solutions 26.0 (SPSS). Crosstabs were used to calculate descriptive statistics for the data presented in this report. To be representative of Perry County, the adult data collected was weighted by age, gender, race, and income using Census data (Note: income data throughout the report represents annual household income). Multiple weightings were created based on this information to account for different types of analyses. For more information on how the weightings were created and applied, see Appendix III.

LIMITATIONS

As with all county health assessments, it is important to consider the findings with respect to all possible limitations. If any important differences existed between the respondents and the non-respondents regarding the questions asked, this would represent a threat to the external validity of the results (the generalizability of the results to the population of Perry County). If there were little to no differences between respondents and non-respondents, then this would not be a limitation. Furthermore, while the survey was mailed to random households in Perry County, those responding to the survey were more likely to be older. While weightings are applied during calculations to help account for this sort of variation, it still presents a potential limitation to the extent that the

lower response from younger individuals might be substantively different from the majority of Perry County residents.

Additionally, 2,000 participants were mailed the advance letter and 3,000 participants were mailed the survey packet in an effort to increase the sample size. This means that many potential respondents did not receive the advance letter that notifies them to anticipate an upcoming survey. It is possible the potential respondents who received the survey without an advance notice may not have felt as inclined to participate as the respondents who received both the advance letter and the survey packet.

It is important to note that, although several questions were asked using the same wording as the CDC questionnaire, the adult data collection method differed. CDC adult data were collected using a set of questions from the total question bank and adults were asked the questions over the telephone rather than via mail survey.

Lastly, caution should be used when interpreting subgroup results, as the margin of error for any subgroup is higher than that of the overall survey.

COVID-19

Data collection occurred during the COVID-19 pandemic. It is important to consider the pandemic when reviewing the report due to the influence the pandemic may have on changes with the health status of the community.

Secondary Data Collection Methods

HCNO collected secondary data, including county-level data, from multiple sources whenever possible. HCNO utilized sources such as the Behavioral Risk Factor Surveillance System (BRFSS), numerous CDC webpages, U.S. Census data, Healthy People 2030, and other national and local sources. All primary data in this report is from the 2021 Perry County Community Health Assessment (CHA). All other data is cited accordingly.

Mobilizing for Action through Planning & Partnerships (MAPP) Process Overview

National Public Health Accreditation status through the Public Health Accreditation Board (PHAB) requires Community Health Assessments (CHAs) to be completed at least every five years. The purpose of the community health assessment is to learn about the health of our community, including health issues and disparities, contributing factors that impact health outcomes, and community assets and resources that can be mobilized to improve population health.

This 2021 CHA was developed using the Mobilizing Action through Partnerships and Planning (MAPP) process, which is a nationally adopted framework developed by the National Association of County and City Health Officials (NACCHO) (see Figure 1.1). MAPP is a community-driven planning process for improving community health and is flexible in its implementation, meaning that the process does not need to be completed in a specific order. This CHA process was facilitated by HCNO in collaboration with a broad range of local agencies representing a variety of sectors of the community. This CHIP (community health improvement plan) process will be facilitated by Ohio University and involves the following six phases:

1. Organizing for success and partnership development

During this first phase, community partners organize the planning process and develop the planning partnership. The purpose of this phase is to structure a planning process that builds commitment, engages participants as partners, uses participant's time well, and results in a plan that can be realistically implemented.

2. Visioning

During the second phase, visioning guides the community through a collaborative process that leads to a shared community vision and common values.

3. The four assessments

While each assessment yields valuable information, the value of the four MAPP assessments is multiplied considering results as a whole. The four assessments include: The Community Health Status Assessment (CHSA), the Local Public Health System Assessment (LPHSA), the Forces of Change (FOC) Assessment, and the Community Themes and Strengths Assessment (CTSA).

4. Identifying strategic issues

The process to formulate strategic issues occurs during the prioritization process of the CHA/CHIP. The committee considers the results of the assessments, including data collected from community members (primary data) and existing statistics (secondary data) to identify key health issues. Upon identifying the key health issues, an objective ranking process is used to prioritize health needs for the CHIP.

5. Formulate goals and strategies

Following the prioritization process, a gap analysis is completed in which committee members identify gaps within each priority area, identify existing resources and assets, and potential strategies to address the priority health needs. Following this analysis, various goals, objectives, and strategies are presented to the committee to meet the prioritized health needs.

6. Action cycle

The committee begins implementation of strategies as part of the next community health improvement cycle. Both progress data to track actions taken as part of the CHIP's implementation and health outcome data (key population health statistics from the CHA) are continually tracked through ongoing meetings. At the end of the CHIP cycle, partners review progress to select new and/or updated strategic priorities based on progress and the latest health statistics.

2019 Ohio State Health Assessment (SHA)


The 2019 Ohio State Health Assessment (SHA) provides data needed to inform health improvement priorities and strategies in the state. This assessment includes over 140 metrics, organized into data profiles, as well as information gathered through five regional forums, online surveys completed by over 300 stakeholders, and advisory and steering committee members who represented 13 state agencies, including sectors beyond health.

Similar to the 2019 Ohio SHA, the 2021 Perry County Community Health Assessment (CHA) examined a variety of metrics from various areas of health including, but not limited to, health behaviors, chronic disease, access to health care, and social determinants of health. Additionally, the CHA studied themes and perceptions from local public health stakeholders from a wide variety of sectors. **Note: This symbol** will be displayed in the trend summary when an indicator directly aligns with the 2019 Ohio SHA.

The interconnectedness of Ohio's greatest health challenges, along with the overall consistency of health priorities identified in this assessment, indicates many opportunities for collaboration among a wide variety of partners at and between the state and local level, including physical and behavioral health organizations and sectors beyond health. It is Perry County's hope that this CHA will serve as a foundation for such collaboration.

FIGURE 1.1 | Components of the 2019 State Health Assessment (SHA)



HEALTH CARE COVERAGE

In 2021, 9% of Perry County adults were without health care coverage. Those most likely to be uninsured were males (14%) and those with annual income levels under \$25,000 (16%).




ACCESS AND UTILIZATION

More than two-thirds (69%) of Perry County adults went outside of Perry County for health care services in the past year. One-fourth (25%) of adults looked for a program to help with depression, anxiety, or some mental health problem.

PREVENTIVE MEDICINE


More than half (56%) of Perry County adults had a flu vaccine during the past year. More than two-thirds (69%) of adults ages 65 and older had a pneumonia vaccination at some time in their life.

WOMEN'S HEALTH

In 2021, nearly half (46%) of Perry County women older than the age of 40 reported having a mammogram in the past year. In the past year, 48% of Perry County women had a clinical breast exam, and 42% had a Pap smear to detect cancer of the cervix. Nearly half (48%) were obese, 30% had high blood pressure, 30% had high blood cholesterol, and 22% were identified as current smokers, of which are all known risk factors for cardiovascular diseases.




MEN'S HEALTH

More than three-fifths (62%) of Perry County men had a prostate-specific antigen test (PSA) in their lifetime, and 37% had one in the past year. More than half (51%) of men had been diagnosed with high blood cholesterol, 50% had high blood pressure, and 12% were identified as smokers, which, along with obesity (47%), all of which are known risk factors for cardiovascular diseases.

ORAL HEALTH

More than half (56%) of Perry County adults visited a dentist or dental clinic in the past year. Nearly one-third (30%) of adults did not see a dentist in the past year due to cost.





HEALTH STATUS PERCEPTIONS


In 2021, 43% of Perry County adults rated their health status as excellent or very good. Conversely, 18% of adults described their health as fair or poor, increasing to 42% of those with annual incomes less than \$25,000.

ADULT WEIGHT STATUS


Nearly three-fourths (73%) of Perry County adults were overweight (26%) or obese (47%) based on body mass index (BMI). Nineteen percent (19%) of adults did not participate in any physical activity in the past week, including 4% who were unable to exercise.

ADULT TOBACCO USE


In 2021, 18% of Perry County adults were current smokers, and 25% were considered former smokers. Eight percent (8%) of adults used e-cigarettes or vapes in the past year. Seventy-three percent (73%) of adults reported they would support an ordinance to ban smoking in a vehicle with a minor present.

ADULT ALCOHOL CONSUMPTION


More than half (53%) of Perry County adults had at least one alcoholic drink in the past month. Twenty-one percent (21%) of adults reported they had five or more alcoholic drinks (for males) or four or more drinks (for females) on one occasion in the last month and would be considered binge drinkers.

ADULT DRUG USE

In 2021, 3% of Perry County adults reported they had used recreational marijuana during the past 6 months. Seven percent (7%) of adults had used medication not prescribed for them or took more than prescribed to feel good or high and/or more active or alert during the past 6 months.

ADULT SEXUAL BEHAVIOR

Nearly three-fourths (72%) of Perry County adults had sexual intercourse in the past year. Five percent (5%) of adults had more than one partner.

ADULT MENTAL HEALTH


Eight percent (8%) of Perry County adults considered attempting suicide in the past year. One-fifth (20%) of adults had a period of two or more weeks when they felt sad or hopeless nearly every day that they stopped doing usual activities in the past year.

CARDIOVASCULAR HEALTH

Seven percent (7%) of adults had survived a heart attack and 5% had survived a stroke at some time in their life. Nearly half of adults were obese (47%), 38% had high blood pressure, 38% had high blood cholesterol, and 18% were current smokers, which are four known risk factors for heart disease and stroke.



CANCER


In 2021, 13% of Perry County adults had been diagnosed with cancer at some time in their life. The Ohio Department of Health (ODH) indicates that, from 2017-to-2019, cancers caused 22% (241) of all (1,120) Perry County resident deaths.

ARTHRITIS

More than one-third (36%) of Perry County adults were diagnosed with arthritis.

ASTHMA


In 2021, 14% of Perry County adults reported they were diagnosed with asthma at some time in their lifetime.


DIABETES

In 2021, 11% of Perry County residents reported they were diagnosed with diabetes at some time in their lifetime. Thirty percent (30%) of adults with diabetes rated their health as fair or poor.



QUALITY OF LIFE

In 2021, 23% of Perry County adults were limited in some way because of a physical, mental or emotional problem. The most limiting health problems were back or neck problems (71%); arthritis/rheumatism (40%); chronic pain (30%); walking problems (30%); and stress, depression, anxiety and emotional problems (24%).





SOCIAL DETERMINANTS OF HEALTH

In 2021, 8% of Perry County adults had to choose between paying bills and buying food. Eighteen percent (18%) of adults experienced four or more adverse childhood experiences (ACEs) in their lifetime (ACEs are stressful or traumatic events, for example, parents becoming separated or divorced, or living with someone who was a problem drinker or alcoholic).

ENVIRONMENTAL HEALTH

Perry County adults reported the following as the top three issues that threatened their health in the past year: insects (11%), rodents (11%), and mold (8%). Seventeen percent (17%) of adults felt their household was well prepared to handle a large-scale disaster or emergency.

PARENTING

In the past year, 80% of adults talked to their child ages 12-to-17-year-old about a career plan/post-secondary education, weight status, and social media issues. Eighty-six percent (86%) of parents took their child to a doctor/health care provider for regular check-ups.





Health Care Access: Access and Utilization

Key Findings

More than two-thirds (69%) of Perry County adults went outside of Perry County for health care services in the past year. One-fourth (25%) of adults looked for a program to help with depression, anxiety, or some mental health problem.

During the past year, 14% of adults or approximately 3,654 adults did not receive medical care due to cost.

- In the past year, 14% of adults needed to see a doctor/health care provider but could not because of cost, increasing to 26% of those with incomes less than \$25,000.
- The following might prevent Perry County adults from getting medical care if they were sick, injured, or need some type of health care: cost/no insurance (23%), difficult to get an appointment (17%), worried they might find something wrong (16%), inconvenient hours (14%), could not get time off work (14%), provider would not take their insurance (12%), frightened of the procedure or doctor/health care provider (12%), could not find childcare (7%), difficult to find/no transportation (3%), did not trust or believe doctors/health care providers (1%), and some other reason (4%).
- Sixty-nine percent (69%) of adults went outside of Perry County for the following health care services in the past year: specialty care (40%); dental services (23%); obstetrics/genecology (20%); dermatological care (19%); primary care (17%); orthopedic care (16%); female health services (12%); cardiac care (11%); pediatric care (9%); mental health care/counseling services (7%); ear, nose, throat care (7%); pediatric therapies (6%); podiatry care (5%); addiction services (3%); cancer care (3%); bariatric care (2%); skilled nursing rehabilitation (2%); hospice/palliative care (2%); and another service (10%).





Key Findings

In 2021, nearly half (46%) of Perry County women older than the age of 40 reported having a mammogram in the past year. In the past year, 48% of Perry County women had a clinical breast exam, and 42% had a Pap smear to detect cancer of the cervix. Nearly half (48%) were obese, 30% had high blood pressure, 30% had high blood cholesterol, and 22% were identified as current smokers, of which are all known risk factors for cardiovascular diseases.

Women's Health Screenings

- Fifty-three percent (53%) of women had a mammogram at some time in their life, and one-fourth (25%) had this screening in the past year.
- Nearly half (46%) of women ages 40 and older had a mammogram in the past year, and 61% had one in the past two years.
- Ninety percent (90%) of Perry County women had a clinical breast exam at some time in their life, and 48% had one within the past year. Sixty-one percent (61%) of women ages 40 and older had a clinical breast exam in the past two years.


Pregnancy

- Thirty-one percent (31%) of Perry County women had been pregnant in the past five years.
- During their last pregnancy in the past five years, Perry County women: received prenatal care within the first three months (70%), took a multi-vitamin with folic acid (53%), experienced depression during or after pregnancy (50%), received a dental exam during pregnancy (40%), received WIC services (40%), smoked cigarettes or used other tobacco products (20%), looked for options for an unwanted pregnancy (7%), and did none of the above (20%).

Women's Health Concerns

- Women used the following as their usual source of services for female health concerns: private gynecologist (49%), general or family physician (24%), family planning clinic (6%), community health center (6%), health department clinic (5%), emergency room (1%), and some other kind of place (1%). Nine percent (9%) of women indicated they did not have a usual source of services for female health concerns.
- Major risk factors for cardiovascular disease include smoking, obesity, high blood cholesterol, high blood pressure, physical inactivity, and diabetes. In 2021, the health assessment identified that:
 - 70% of women were overweight or obese (2019 BRFSS reports 66% for Ohio and 60% for U.S.)
 - 30% were diagnosed with high blood pressure (2019 BRFSS reports 32% for Ohio and 32%* for U.S.)

Five Minutes for Women's Health

The CDC released five things women can do that can go a long way to improve or maintain good health. In five minutes or less women can:

- Learn about the number one killer of women: Heart disease is the leading cause of death for women
 in the U.S. Learn the symptoms of heart attack and stroke.
- Schedule a check-up: Regular check-ups are important. Schedule an appointment with your provider to
 discuss screenings and exams you need and when they are needed.
- Protect your skin from the sun: Skin cancer is the most common cancers among women in the U.S.
 Protect your skin and wear a broad-spectrum sunscreen before you go outside.
- Find an HIV, STD, and hepatitis testing site near you: Untreated STDs can have long-term consequences for women, such as infertility.
- Take folic acid before and during pregnancy: Folic acid can help prevent certain birth defects. If a
 woman has enough folic acid in her body before/during pregnancy, her baby may be less likely to have
 certain birth defects.

What is Prostate Cancer Screening?

Cancer screening means looking for cancer before it causes symptoms. The goal of screening is to find cancer early that may spread if not treated. There is no standard test to screen for prostate cancer. Two different tests are commonly used to screen for prostate cancer. Talk to your doctor about the below screenings if you are thinking about being screened:

A blood test called a prostate specific antigen (PSA) test

o PSA is a substance the prostate makes. This test measures the level of PSA a man's blood. The PSA level may be high if a man has prostate cancer and for many reasons, such as having an enlarged prostate, a prostate infection, or taking certain medicines.

A digital rectal examination

A digital rectal exam is when a health care provide inserts a gloved, lubricated finger into a man's rectum to feel the prostate for anything abnormal, such as cancer.



Men and Heart Disease*

Heart disease is the leading cause of death for men in the United States, killing 357,761 men in 2019—that's about 1 in every 4 male deaths.

- About 1-in -3 (7.7%) white men and 1-in-14 (7.1%) black men have coronary heart disease. About 1-in-17 (5.9%) Hispanic men have coronary heart disease.
- Half of the men who die suddenly of coronary heart disease had no previous symptoms. Even if you have no symptoms, you may still be at risk for heart disease.

High blood pressure, high LDL (low-density lipoprotein) cholesterol, and smoking are key risk factors for heart disease. In 2013-2016, about half of American men (47%) had hypertension. Several other medical conditions and lifestyle choices can also put people at a higher risk for heart disease, including the following:

- Diabetes
- Overweight and obesity
- Unhealthy diet
- Physical inactivity
- Excessive alcohol use

To reduce your chances of getting heart disease, it's important to do the following:

- Know your blood pressure. Having uncontrolled blood pressure can result in heart disease. High blood pressure has no symptoms so it's important to have your blood pressure checked regularly.
- Talk to your health care provider about whether you should be tested for diabetes. Having diabetes raises your risk of heart disease.
- Quit smoking. If you don't smoke, don't start. If you do smoke, learn ways to quit.
- Discuss checking your cholesterol and triglyceride levels with your health care provider.
- Make healthy food. Being overweight or obesity raises your risk of heart disease.
- Limit alcohol intake to one drink a day.
- Lower your stress level and find healthy ways to cope with stress.

More than half (56%) of Perry County adults visited a dentist or dental clinic in the past year. Nearly one-third (30%) of adults did not see a dentist in the past year due to cost.


During the past year, 56% of adults or approximately 14,615 Perry County adults visited a dentist or dental clinic.

Oral Health

- In the past year, 56% of Perry County adults had visited a dentist or dental clinic, decreasing to 33% of those with annual incomes less than \$25,000.
- Sixty-five percent (65%) of Perry County adults with dental insurance had been to the dentist in the past year, compared to 52% of those without dental insurance.
- Adults reported the following reasons for not visiting a dentist in the last year:
 - Cost (30%)
 - Fear, apprehension, nervousness, pain, and dislike going (26%)
 - Had dentures (22%)
 - Did not have/know a dentist (6%)
 - Other reasons (17%)

Facts About Adult Oral Health

- The baby boomer generation is the first where most people will keep their natural teeth over their entire lifetime. This is largely because of the benefits of water fluoridation and fluoride toothpaste. However, threats to oral health, including tooth loss, continue throughout life.
- The major risks for tooth loss are tooth decay and gum disease that may increase with age because of problems with saliva production; receding gums that expose "softer" root surfaces to decay-causing bacteria; or difficulties flossing and brushing because of poor vision, cognitive problems, chronic disease, and physical limitations.
- Although more adults are keeping their teeth, many continue to need treatment for dental problems. This need is even greater for members of some racial and ethnic groups—about three-in-four (75%) Hispanics and non-Hispanic black adults have an unmet need for dental treatment, as do people who are poor. These individuals are also more likely to report having poor oral health.
- In addition, some adults may have difficulty accessing dental treatment. For every adult aged 19 years or older without medical insurance, there are three who don't have dental insurance.
- Oral health problems include the following: untreated tooth decay, gum disease, tooth loss, oral cancer, and chronic diseases such as arthritis, heart disease, and stroke.

Key Findings


In 2021, 43% of Perry County adults rated their health status as excellent or very good. Conversely, 18% of adults described their health as fair or poor, increasing to 42% of those with annual incomes less than \$25,000.

18% of adults, or approximately 4,698 of Perry County adults rated their general health as fair or poor.

General Health Status

- Forty-three percent (43%) of Perry County adults rated their health as excellent or very good. Perry County adults with higher annual incomes (49%) were most likely to rate their health as excellent or very good, compared to 26% of those with annual incomes less than \$25,000.
- Eighteen percent (18%) of adults rated their health as fair or poor.
- Perry County adults were most likely to rate their health as fair or poor if they:
 - Had an annual household income less than \$25,000 (42%)
 - Were divorced (41%)
 - Had been diagnosed with diabetes (30%)
 - Had high blood pressure (29%) or high blood cholesterol (27%)
- Thirty-seven percent (37%) of adults reported that poor mental or physical health kept them from doing usual activities such as self-care, work, or recreation.

The following graph shows the percentage of Perry County adults who described their personal health status as excellent/very good, good, and fair/poor. Examples of how to interpret the information include: 43% of Perry County adults, 26% of those with incomes less than \$25,000, and 45% of those ages 65 and older rated their health as excellent or very good.

Physical Health Status

- More than one-quarter (27%) of Perry County adults rated their physical health as not good on four or more days in the previous month.
- Perry County adults reported their physical health as not good on an average of 5.5 days in the previous month.
- Perry County adults were most likely to rate their physical health as not good (on four or more days during the past month) if they:
 - Had an annual household income less than \$25,000 (60%)

Mental Health Status

- More than two-fifths (42%) of Perry County adults rated their mental health as not good on four or more days in the previous month.
- Perry County adults reported their mental health as not good on an average of 7.4 days in the previous month.
- Perry County adults were most likely to rate their mental health as not good (on four or more days during the past month) if they:
 - Had an annual household income less than \$25,000 (63%)
 - Were female (52%)

Health Behaviors: Adult Weight Status

Key Findings

Nearly three-fourths (73%) of Perry County adults were overweight (26%) or obese (47%) based on body mass index (BMI). Nineteen percent (19%) of adults did not participate in any physical activity in the past week, including 4% who were unable to exercise.


47% of Perry County adults or approximately 12,267 adults were obese.

Adult Weight Status

- Nearly three-fourths (73%) of Perry County adults were either overweight (26%) or obese (47%) by body mass index (BMI), putting them at elevated risk for developing a variety of diseases.
- Perry County adults did the following to lose weight or keep from gaining weight in the past month: exercised (44%); ate less food, fewer calories, or foods low in fat (37%); drank more water (35%); ate a low-carb diet (18%); took diet pills, powders or liquids without a doctor's advice (5%); smoked cigarettes (4%); went without eating 24 or more hours (4%); health coaching (2%); used a weight loss program (2%); and took prescribed medications (2%).

The following graph shows the percentage of Perry County adults who are overweight or obese by body mass index (BMI). Examples of how to interpret the information include: 27% of all Perry County adults were classified as normal weight, 26% were overweight, and 47% were obese.

Physical Activity

- In Perry County, 60% of adults engaged in some type of physical activity or exercise for at least 30 minutes 3 or more days per week. Thirty-one percent (31%) of adults exercised 5 or more days per week. Nineteen percent (19%) of adults did not participate in any physical activity in the past week, including 4% who were unable to exercise.
- Perry County adults spent the most time doing the following physical activities in the past year: walking (29%), manual labor/chores (15%), occupational exercise (5%), strength training (3%), running/jogging (1%), exercise machines (1%), and other (1%). Thirty-one percent (31%) of adults engaged in multiple types of exercise.


Summary of the American Cancer Society (ACS) Guidelines on Nutrition and Physical Activity

- 1. Achieve and maintain a healthy weight throughout life
 - Be as lean as possible throughout life without being underweight.
 - Avoid excess weight gain at all ages. For those who are overweight or obese, losing even a small amount of weight has health benefits and is a good place to start.
 - Get regular physical activity and limit intake of high calorie foods and drinks as keys to help maintain a healthy weight.
- 2. Be physically active
 - Get at least 150-300 minutes of moderate intensity or 75-150 minutes of vigorous intensity activity each week (or a combination of these), preferably spread throughout the week.
 - Limit sedentary behavior such as sitting, lying down, watching TV, and other forms of screen-based entertainment.
 - Doing some physical activity above usual activities, no matter what one's level of activity, can have many health benefits.
- 3. Eat a healthy diet, with an emphasis on plant foods
 - Choose foods and drinks in amounts that help you get to and maintain a healthy weight.
 - Eat a variety of vegetables and whole fruits.
 - Choose whole grains instead of refined grain products.

Health Behaviors: Adult Tobacco Use

Key Findings

In 2021, 18% of Perry County adults were current smokers, and 25% were considered former smokers. Eight percent (8%) of adults used e-cigarettes or vapes in the past year. Seventy-three percent (73%) of adults reported they would support an ordinance to ban smoking in a vehicle with a minor present.

18% of Perry County adults, or approximately 4,698 adults were current smokers.

Adult Tobacco Use Behaviors

- Eighteen percent (18%) of Perry County adults were current smokers (those who indicated smoking at least 100 cigarettes in their lifetime and currently smoked some or all days).
- One-quarter (25%) of adults indicated that they were former smokers (smoked 100 cigarettes in their lifetime and now do not smoke).
- Perry County adult smokers were more likely to have:
 - Rated their overall health as fair or poor (45%)
 - Been diagnosed with asthma (35%)
 - Annual incomes less than \$25,000 (33%)
 - A member of an unmarried couple (33%) or divorced (32%)
- Perry County adults used the following tobacco products in the past year: cigarettes (23%); chewing tobacco, snuff, or snus (13%); e-cigarette/vapes (8%); cigars (3%); little cigars (2%); cigarillos (2%); and pipes (2%).
- One-third (33%) of current smokers responded that they had stopped smoking for at least one day in the past year because they were trying to quit smoking.
- Adults reported using e-cigarettes or other electronic vapor products: everyday (2%), some days (5%), and not at all (93%).
- Perry County adults had the following rules/practices about smoking in their home: never allowed (74%), not allowed with children around (16%), allowed anywhere (13%), and allowed only in certain rooms (2%).
- Perry County adults had the following rules/practices about smoking in their car: never allowed (74%), allowed only when one or more windows are open (14%), not allowed with children around (11%), and allowed anytime (8%).
- Perry County adults reported they would support an ordinance to ban smoking in the following places:
 - Vehicle with a minor present (73%)
 - Multi-unit housing (57%)
 - Rental homes (55%)
 - Parks or ball fields (50%)
 - College/university campuses (49%)
 - Fairgrounds (46%)
- Twenty percent (20%) of Perry County adults reported they would not support an ordinance to ban smoking anywhere.
- More than two-thirds (68%) of Perry County adults indicated they believed e-cigarette vapor was harmful to themselves, and more than half (55%) believed it was harmful to others. Three percent (3%) of adults did not believe e-cigarette vapor was harmful to anyone, and 24% did not know if e-cigarette vapor was harmful.

E-Cigarette Health Effects


- Most e-cigarettes contain nicotine, which has known health effects.
 - Nicotine is highly addictive.
 - Nicotine is toxic to developing fetuses.
 - Nicotine can harm adolescent brain development, which continues into the early-to-mid-20s.
 - Nicotine is a health danger for pregnant women and their developing babies.
- The e-cigarette aerosol that users breathe from the device and exhale can contain both harmful and potentially harmful substances.
 - This includes nicotine; ultrafine particles that can be inhaled deep into the lungs; flavoring such as diacetyl, a chemical linked to a serious lung disease; volatile organic compounds; cancer-causing chemicals; and heavy metals such as nickel, tin, and lead.
 - It is difficult for consumers to know what e-cigarette products contain. For example, some e-cigarettes marketed as containing zero percent nicotine have been found to contain nicotine.
 - Additionally, this includes cancer-causing chemicals and tiny particles that reach deep into lungs.
 However, e-cigarette aerosol generally contains fewer harmful chemicals than smoke from burned tobacco products.

• E-cigarettes can cause unintended injuries.

- Defective e-cigarette batteries have caused fires and explosions, some of which have resulted in serious injuries. Most explosions happened when the e-cigarette batteries were being charged.
- The Food and Drug Administration (FDA) collects data to help address this issue.
- In addition, acute nicotine exposure can be toxic. Children and adults have been poisoned by swallowing, breathing, or absorbing e-cigarette liquid through their skin or eyes.
- E-cigarettes are less harmful than regular cigarettes, but that doesn't mean they are safe.
 - E-cigarette aerosol generally contains fewer toxic chemicals than the deadly mix of 7,000 chemicals in smoke from regular cigarettes. However, e-cigarette aerosol is not harmless. It can contain harmful and potentially harmful substances, including nicotine, heavy metals like lead, volatile organic compounds, and cancer-causing agents.
 - E-cigarettes are not currently approved by the FDA as a smoking cessation aid. The U.S. Preventive Services Task Force, a group of health experts that makes recommendations about preventive health care, has concluded that evidence is insufficient to recommend e-cigarettes for smoking cessation in adults, including pregnant women. However, according to the CDC, e-cigarettes may help non-pregnant adult smokers if used as a complete substitute for all cigarettes and other smoked tobacco products.

Cost of Smoking

Smoking leads to disease and disability, and it harms nearly every organ of the body.

- More than 16 million Americans are living with a disease caused by smoking.
- For every person who dies because of smoking, at least 30 people live with a serious smoking-related illness.
- Smoking causes cancer, heart disease, stroke, lung diseases, diabetes, and chronic obstructive pulmonary disease (COPD), which includes emphysema and chronic bronchitis.
- Smoking also increases the risk for tuberculosis, certain eye diseases, and problems of the immune system, including rheumatoid arthritis.
- Smoking is a known cause of erectile dysfunction in males.

Smoking is the leading cause of preventable death.

- Worldwide, tobacco use causes more than 7 million deaths per year. If the pattern of smoking all over the globe doesn't change, more than 8 million people a year will die from diseases related to tobacco use by 2030.
- Cigarette smoking is responsible for more than 480,000 deaths per year in the United States, including more than 41,000 deaths resulting from secondhand smoke exposure. This is about one in five deaths annually, or 1,300 deaths every day.
- On average, smokers die 10 years earlier than nonsmokers.
- If smoking continues at the current rate among U.S. youth, 5.6 million of today's Americans younger than 18 years of age are expected to die prematurely from a smoking-related illness. This represents about one in every 13 Americans aged 17 years or younger who are alive today.

Smoking costs the United States billions of dollars each year. Total economic cost of smoking is more than \$300 billion a year, including the following costs:

- Nearly \$170 billion in direct medical care for adults.
- More than \$156 billion in lost productivity due to premature death and exposure to secondhand smoke.

Health Behaviors: Adult Alcohol Consumption

Key Findings

More than half (53%) of Perry County adults had at least one alcoholic drink in the past month. Twenty-one percent (21%) of adults reported they had five or more alcoholic drinks (for males) or four or more drinks (for females) on one occasion in the last month and would be considered binge drinkers.

21% of Perry County adults, or approximately 5,481 adults, were considered binge drinkers.

Adult Alcohol Consumption

- More than half (53%) of Perry County adults had at least one alcoholic drink in the past month, increasing to 57% of males.
- Of those who drank, adults consumed 4.1 drinks on average, increasing to 5.6 drinks for males.
- More than one-fifth (21%) of Perry County adults reported they had five or more alcoholic drinks (for males) or four or more drinks (for females) on one occasion in the last month and would be considered binge drinkers. Of those who drank in the past month, 53% had at least one episode of binge drinking.
- Fourteen percent (14%) of current drinkers reported driving after having perhaps too much alcohol to drink in the past month.

Drinking and Driving

Drinking and Driving Statistics in the United States


- Driving after drinking is deadly, yet it still happens across the Unites States. While impaired, someone could get arrested or worse, be involved in a traffic crash that cause injury or death.
- Approximately one-third of all traffic crash fatalities in the United States involve drunk drivers (with blood alcohol concentration of .08 grams of alcohol per deciliter (g/dL) or higher). In 2018, there were 10,511 people killed in these preventable crashes.
- On average, over the 10-year period from 2009-2018, more than 10,000 people died every year in drunk-driving crashes.
- In every state, it is illegal to drive with a blood alcohol concentration of .08 or higher, yet, in 2018, one person was killed in a drunk driving crash every 50 minutes in the United States.
- Men are more likely to be driving drunk in fatal crashes. In 2018, 21% of men were drunk in these crashes compared to 14% of women.

How alcohol affects driving ability


- As alcohol levels rise in a person's system, the negative effects on the central nervous system increase.
- Alcohol is absorbed directly through the walls of the stomach and small intestine. It then passes into the bloodstream, where it accumulates until it is metabolized by the liver. This is called blood alcohol concentration, or BAC.
- At a BAC level of .08 grams of alcohol per deciliter (g/dL) of blood, the risk for crash increases exponentially. Because of this risk, it's illegal in all 50 states to drive with a BAC of .08 or higher.
- In 2018, there were 1,878 people killed in alcohol-related crashed where drivers had BACs below the legal threshold for drunk driving (i.e., BACs below .08 g/dL)


In 2021, 3% of Perry County adults reported they had used recreational marijuana during the past 6 months. Seven percent (7%) of adults had used medication not prescribed for them or took more than prescribed to feel good or high and/or more active or alert during the past 6 months.

- Three percent (3%) of Perry County adults reported using recreational marijuana or hashish in the past 6 months.
- Perry County adults reported that they and/or an immediate family member/someone in their household took
 the following medications not prescribed to them to feel good, high and/or more active or alert during the past
 6 months:
 - Tranquilizers such as Valium or Xanax (8%)
 - Steroids (5%)
 - Vicodin (5%)
 - Codeine, Demerol, Morphine, Percocet, Dilaudid, or Fentanyl (5%)
 - Suboxone or Methadone (2%)
 - Neurontin (2%)
 - Ritalin, Adderall, Concerta, or other ADHD medication (1%)
 - OxyContin (1%)
- Seven percent (7%) of Perry County adults reported misusing prescription medication in the past 6 months, increasing to 14% of those with incomes less than \$25,000.
- Perry County adults did the following with unused prescription medication: took as prescribed (38%), threw it in the trash (20%), kept it (16%), flushed it down the toilet (14%), took it to the medication collection program (13%), took it in on national drug take back day (6%), kept it in a locked cabinet (6%), took it to the sheriff's office (2%), used drug deactivation pouches (1%), gave it away (1%), sold it (1%), and other disposal methods (1%). More than one-third of adults (39%) did not have unused prescription medication.



Perry County Adult Recreational Marijuana Use in the Past 6 Months





Perry County Adult Medication Misuse in the Past 6 Months















Perry County and Ohio Number of Opioid Doses Per Capita, Quarterly from 2018-2020




Number of Opioid Doses Per Patient, Quarterly from 2018-2020


Key Findings

Nearly three-fourths (72%) of Perry County adults had sexual intercourse in the past year. Five percent (5%) of adults had more than one partner.

Adult Sexual Behavior

- Nearly three-fourths (72%) of Perry County adults had sexual intercourse in the past year.
- Five percent (5%) of adults reported they had intercourse with more than one partner in the past year, increasing to 12% of those with incomes less than \$25,000.
- Adults used the following methods of birth control: they or their partner were too old to get pregnant (16%); male sterilization (vasectomy) (15%); birth control pills, any kind (14%); male or female condoms (12%); withdrawal (12%); female sterilization (tubes tied) (10%); IUD (e.g., Mirena) (6%); contraceptive implant (e.g., Nexplanon) (6%); hysterectomy (3%); having sex at certain times (rhythm or natural family planning) (3%); had ovaries or testicles removed (3%); they or their partner were infertile (2%); gay or lesbian (2%); practicing abstinence (2%); contraceptive ring (e.g., NuvaRing) (2%); copper-bearing IUD (e.g., ParaGard) (2%); shots (e.g., Depo-Provera) (1%); and no partner/not sexually active (1%).
- Eleven percent (11%) of Perry County adults were not using any method of birth control; 5% were pregnant and 10% were trying to get pregnant.












Unintended Pregnancy

- The concept of unintended pregnancy helps in understanding the fertility of populations and the unmet need for contraception, also known as birth control, and family planning. Most unintended pregnancies result from not using contraception or from not using it consistently or correctly.
- Unintended pregnancy is associated with an increased risk of problems for the mom and baby. If the mom was not planning to get pregnant, she may have unhealthy behaviors or delay getting health care during the pregnancy, which could affect the health of the baby. Therefore, it is important for all women of reproductive age to adopt healthy behaviors such as:
 - Take folic acid
 - Maintain a healthy diet and weight
 - Be physically active regularly
 - Quit tobacco use
 - Refrain from excessive alcohol drinking
 - Abstain from alcohol if pregnant or planning to become pregnant
 - Take only medicines prescribed by your doctor
 - Talk to your health care provider about screening and proper management of chronic diseases
 - Visit your health care provider to receive recommended health care for your age, learn about possible health risks, and discuss if or when you are considering becoming pregnant
 - Use effective contraception correctly and consistently if you are sexually active but choose to delay or avoid pregnancy
- The CDC is working on many things to help prevent unintended pregnancy, such as:
 - o Increase access, use, and dissemination of data to identify groups most at risk for unintended pregnancy; show the health impacts of teen and unintended pregnancy; and close gaps in access to quality, patient-centered family planning services.
 - Develop and identify evidence-based strategies to reduce unmet needs for quality family planning services among the most affected groups.
 - o Provide guidance for health care providers who counsel men, women, and couples about contraception.
 - Build capacity for health care providers, states, communities, and partners to improve quality patient-centered family planning services and support states and communities to increase access to contraception services.


Eight percent (8%) of Perry County adults considered attempting suicide in the past year. One-fifth (20%) of adults had a period of two or more weeks when they felt sad or hopeless nearly every day that they stopped doing usual activities in the past year.

8% of Perry County adults, or approximately 2,088 adults seriously considered attempting suicide in the past year.

Adult Mental Health

- During the past year, 20% of Perry County adults felt so sad or hopeless almost every day for two weeks or more in a row that they stopped during usual activities.
- Thirty-two percent (32%) of adults were told they had a depressive disorder (including depression, major depression, dysthymia, or minor depression).
- Eight percent (8%) of Perry County adults seriously considered attempting suicide in the past year.
- No adults reported actually attempting suicide in the past year.
- Perry County adults reported they or someone in their household were diagnosed with or treated for the following mental health issues in the past year:
 - Depression (32%)
 - Anxiety or emotional problems (28%)
 - Anxiety disorder (panic attacks, phobia, obsessive-compulsive disorder) (27%)
 - Alcohol and/or illicit drug abuse (8%)
 - Attention deficit disorder (ADD/ADHD) (7%)
 - Post-traumatic stress disorder (PTSD) (6%)
 - Eating disorder (5%)

- Bipolar disorder (5%)
- Other trauma (3%)
- Developmental disability (3%)
- Psychotic disorder (schizophrenia, schizoaffective disorder) (3%)
- Gambling problem (1%)
- Autism spectrum (1%)
- Other mental health disorder (2%)
- Twenty-three percent (23%) of adults indicated they or someone in their household have taken medication for one or more mental health issues.
- Perry County adults reported the following caused them anxiety, stress or depression: job stress (39%), financial stress (33%), current news/political environment (31%), death of close family member or friend (25%), sick family member (22%), marital/dating relationships (20%), poverty/no money (19%), raising/caring for children (17%), fighting in the home (16%), other stress at home (10%), social media (9%), caring for a parent (8%), divorce/separation (8%), unemployment (7%), family member with a mental illness (6%), not feeling safe in the community (2%), not feeling safe at home (2%), not having enough to eat (1%), sexual orientation/gender identity (1%), and other causes (16%).
- Fifteen percent (15%) of Perry County adults had used a program or service for themselves or someone in their households to help with depression, anxiety, or emotional problems. The following prevented adults from using a program: had not thought of it (9%), embarrassed to see mental health services (9%), co-pay/deductible too high (6%), fear (6%), took too long to get in to see a doctor/health care provider (6%), stigma of seeking mental health services (6%), did not know how to find a program (4%), could not afford to go (4%), could not find a mental health doctor or provider (3%), could not find a provider to address both mental health and disability (2%), other priorities (2%), transportation (1%), the clinic their insurance covered was too far away (1%), and other reasons (6%). Fifty-two percent (52%) of adults indicated they did not need such a program.

Suicide in the United States

Fatal Outcomes

- In 2019, suicide ranked as the 10th leading cause of death overall in the U.S. and ranked as the 2nd leading cause of death for those ages 15-34.
- In 2019, there was a total of 47,511 suicides, equating to an age-adjusted rate of 13.9 suicides per 100,000 people. Firearms accounted for half (50.4%) of these suicides, amounting to 23,941 suicides.
- On average, one person died due to suicide in the U.S. every 11.1 minutes.
- Males have a higher rate of fatal suicide, with 3.6 suicide deaths for every female death by suicide.

Non-Fatal Outcomes


- In 2019, 1.2 million Americans attempted suicide. This equates to one suicide attempt every 26.6 seconds.
- Females have a higher rate of attempting suicide, with three females attempting suicide for every male who attempts suicide.


Survivors of Suicide Loss

• As much as 40-50% of the population have been exposed to suicide (those who knew someone personally who died by suicide) in their lifetime. The number of survivors of suicide loss in the U.S. is more than 5.4 million, or 1 out of every 60 Americans in 2019.



Common Signs of Mental Illness in Adults

- Trying to tell the difference between what expected behaviors are and what might be the signs of a mental illness can be difficult. There's no easy test that can let someone know if there is mental illness or if actions and thoughts might be typical behaviors of a person or the result of a physical illness. Knowing the warning signs can help determine if someone needs to speak to a professional. For many people, getting an accurate diagnosis is the first step in a treatment plan.
- Each illness has its own symptoms, but common signs of mental illness in adults can include:
 - Excessive worrying or fear
 - Feeling excessively sad or low
 - Extreme mood changes
 - Avoiding friends and social activities
 - Changing in sleep habits or feeling tired and having low energy
 - Changes in eating habits such as increased hunger or lack of appetite
 - Abuse of substances like alcohol or drugs
 - Inability to carry out daily activities or handle daily problems and stress
- After diagnosis, a health care provider can help develop a treatment plan that could include medication, therapy or other lifestyle changes.
- Getting a diagnosis is just the first step; knowing your own preferences and goals are also important. Treatments for mental illness vary by diagnosis and by person. There's no "one size fits all" treatment. Treatment options can include medication, counseling (therapy), social support and education.

Chronic Disease: Cardiovascular Health

Key Findings

Seven percent (7%) of adults had survived a heart attack and 5% had survived a stroke at some time in their life. Nearly half of adults were obese (47%), 38% had high blood pressure, 38% had high blood cholesterol, and 18% were current smokers, which are four known risk factors for heart disease and stroke.

Heart Disease and Stroke

- Seven percent (7%) of adults reported they were diagnosed with angina or coronary heart disease, increasing to 14% of males.
- Seven percent (7%) of adults reported they had survived a heart attack, increasing to 11% of those over the age of 65 and 13% of males.
- Five percent (5%) of adults reported they had survived a stroke, increasing to 9% of males.
- Three percent (3%) of adults reported they had congestive heart failure, increasing to 6% of those over the age of 65.

High Blood Pressure (Hypertension)

Nearly two-fifths (38%) of adults had been diagnosed with high blood pressure.















Key Findings

In 2021, 13% of Perry County adults had been diagnosed with cancer at some time in their life. The Ohio Department of Health (ODH) indicates that, from 2017-to-2019, cancers caused 22% (241) of all (1,120) Perry County resident deaths.

Adult Cancer

- Thirteen percent (13%) of Perry County adults were diagnosed with cancer at some point in their lifetime, increasing to 25% of those over the age of 65.
- Of those diagnosed with cancer, they reported the following types: melanoma (19%), other skin cancer

(19%), breast (18%), cervical (18%), prostate (14%), head and neck (10%), colon (5%), larynx (5%), rectal (5%), and other types of cancer (5%). Ten percent (10%) of adults were diagnosed with multiple types of cancer.



- The American Cancer Society states that about 608,570 Americans are expected to die of cancer in 2021. Cancer is the second leading cause of death in the U.S., exceeded only by heart disease (Source: American Cancer Society, Facts & Figures 2021).

Cancer Fast Facts

- Cancer is the second leading cause of death in the United States, but many kinds of cancer can be prevented or caught early.
- Leading risk factors for preventable cancers are smoking, getting too much UV radiation from the sun or tanning beds, being overweight or obese, and drinking too much alcohol.
- Some kinds of cancer (like breast, cervical, and colorectal) can be caught early through screening. Other kinds of cancer can be prevented. For example, cervical cancer through vaccination and colorectal cancer can be prevented through removing precancerous growths in the colon and rectum.
- The cost of cancer care in the United States is expected to reach almost \$174 billion by 2020.





Breast Cancer

- In 2021, 48% of Perry County females reported having a clinical breast examination in the past year.
- Nearly half (46%) of Perry County females older than the age of 40 had a mammogram in the past year.
- For women at average risk of breast cancer, recently updated American Cancer Society screening guidelines recommend that those 40-to-44 years of age have the option to begin annual mammography, those 45-to-54 should undergo annual mammography, and those 55 years of age and older may transition to biennial mammography or continue annual mammography. Women should continue mammography as long as overall health is good and life expectancy is 10 or more years. For some women at high risk of breast cancer, annual magnetic resonance imaging (MRI) is recommended in addition to mammography, typically starting at age 30 (Source: American Cancer Society, Facts & Figures 2021).



Prostate Cancer

- More than three-fifths (62%) of Perry County men had a prostate-specific antigen test (PSA) in their lifetime, and 37% had one in the past year.
- ODH statistics indicate that prostate cancer accounted for 6% of all male cancer deaths from 2017-to-2019 in Perry County (Source: Ohio Public Health Data Warehouse, 2017-2019).
- No organizations presently endorse routine prostate cancer screening for men at average risk because of concerns about the high rate of overdiagnosis (detecting disease that would never have caused symptoms or harm), along with the significant potential for serious side effects associated with prostate cancer treatment. The American Cancer Society recommends that beginning at age 50, men who are at average risk of prostate cancer and have a life expectancy of at least 10 years have a conversation with their health care provider about the benefits and limitations of PSA testing and make an informed decision about whether to be tested based on their personal values and preferences. Men at high risk of developing prostate cancer (Black men or those with a close relative diagnosed with prostate cancer before the age of 65) should have this discussion beginning at age 45, and men at even higher risk (those with several close relatives diagnosed at an early age) should have this discussion beginning at age 40 (Source: American Cancer Society, Facts & Figures 2021).




Lung Cancer

- In Perry County, 18% of adults were current smokers and 25% were former smokers.
- ODH reports that lung and bronchus cancer (total deaths=47) was the leading cause of male cancer deaths from 2017-to-2019 in Perry County (Source: Ohio Public Health Data Warehouse, 2017-2019).





- Modifiable factors that increase colorectal cancer risk include obesity, physical inactivity, long-term smoking, high consumption of red or processed meat, low calcium intake, moderate to heavy alcohol consumption, and very low intake of fruits and vegetables and whole-grain fiber. Hereditary and medical factors that increase risk include a personal or family history of colorectal cancer and/or polyps, certain inherited genetic conditions, a personal history of chronic inflammatory bowel disease, and type 2 diabetes (Source: American Cancer Society, Facts & Figures 2021).
- Screening can prevent colorectal cancer through the detection and removal or precancerous growths, as well as detect cancer at an early stage. Regular screenings with either stool tests or exams (e.g., colonoscopy) results in a reduction in premature colorectal cancer death. New guidelines from the American Cancer Society recommend men and women at average risk for colorectal cancer be screened starting at age 45 (Source: American Cancer Society, Facts & Figures 2021).

2021 Cancer Estimates

- In 2021, more than 1.9 million new cancer cases are expected to be diagnosed.
- The World Cancer Research Fund estimates that about 18% of the new cancer cases expected to occur in the U.S. will be related to being overweight or obesity, physical inactivity, and poor nutrition, and thus could be prevented.
- About 608,570 Americans are expected to die of cancer in 2021.
- 80% of lung cancer deaths in the U.S are attributed to smoking.
- In 2021, estimates predict that there will be 73,320 new cases of cancer and 25,140 cancer deaths in Ohio.
- Of the new cancer cases in Ohio, approximately 10,350 (14%) will be from lung and bronchus cancers and 5,860 (8%) will be from colon and rectum cancers.
- About 10,450 new cases of female breast cancer are expected in Ohio.
- New cases of male prostate cancer in Ohio are expected to be 9,010 (12%).





Arthritis: Key Public Health Messages

Early diagnosis of arthritis and self-management activities can help people decrease their pain, improve function, and stay productive.

Key self-management activities include the following:

- 1. Learn arthritis management strategies Arthritis management strategies provide those with arthritis with the skills and confidence to effectively manage their condition. Self-Management Education has proven to be valuable for helping people change their behavior and better manage their arthritis symptoms. Interactive workshops such as the Arthritis Self-Management Program and the Chronic Disease Self-Management Program are low-cost (about \$25 \$35) and available in communities across the country. Attending one of these programs can help a person learn ways to manage pain, exercise safely, and gain control of arthritis.
- **2. Be active** Research has shown that physical activity decreases pain, improves function, and delays disability. Make sure you get at least thirty minutes of moderate physical activity at least five days a week. You can get activity in ten-minute intervals.
- **3. Watch your weight** The prevalence of arthritis increases with increasing weight. Research suggests that maintaining a healthy weight reduces the risk of developing arthritis and may decrease disease progression. A loss of just eleven pounds can decrease the occurrence (incidence) of new knee osteoarthritis and a modest weight loss can help reduce pain and disability.
- **4. See your doctor** Although there is no cure for most types of arthritis, early diagnosis and appropriate management is important, especially for inflammatory types of arthritis. For example, early use of disease-modifying drugs can affect the course of rheumatoid arthritis. If you have symptoms of arthritis, see your doctor and begin appropriate management of your condition.
- **5. Protect your joints** Joint injury can lead to osteoarthritis. People who experience sports or occupational injuries or have jobs with repetitive motions like repeated knee bending have more osteoarthritis. Avoid joint injury to reduce your risk of developing osteoarthritis.



Asthma and Other Respiratory Disease

- In 2021, 14% of Perry County adults reported they were diagnosed with asthma at some time in their lifetime.
- There are several important factors that may trigger an asthma attack. Some of these triggers are tobacco smoke; dust mites; outdoor air pollution; cockroach allergens; pets; mold; smoke from burning wood or grass; and infections linked to the flu, colds, and respiratory viruses (Source: CDC, Asthma, Updated September 6, 2019).
- Chronic lower respiratory disease was the third leading cause of death in Perry County and the fourth leading cause of death in Ohio in 2017-to-2019 (Source: Ohio Public Health Data Warehouse, 2017-2019).







Asthma Facts

- The number of Americans with asthma grows every year. Currently, 26.5 million Americans have asthma.
- More than 3,500 people die of asthma each year, nearly half of whom are age 65 or older.
- Asthma results in 439,000 hospitalizations and 1.3 million emergency room visits annually.
- Annually, patients with asthma reported 11 million visits to a doctor's office and 1.7 million visits to hospital outpatient departments.
- Effective asthma treatment includes monitoring the disease with a peak flow meter, identifying and avoiding allergen triggers, using drug therapies including bronchodilators and anti-inflammatory agents, and developing an emergency plan for severe attacks.





Statistics About Diabetes

- Among the US population overall, crude estimates for 2018 indicated that:
 - 34.2 million people of all ages—or 10.5% of the US population—had diabetes.
 - 34.1 million adults aged 18 years or older—or 13.0% of all US adults—had diabetes.
 - 7.3 million adults aged 18 years or older who met laboratory criteria for diabetes were not aware of or did not report having diabetes. This number represents 2.8% of all US adults and 21.4% of all US adults with diabetes.
 - The percentage of adults with diabetes increased with age, reaching 26.8% among those aged 65 years or older.
- Among adults aged 18 or older in the U.S., 1.5 million new cases, or 6.9 per 1,000 persons, were diagnosed in 2018.
- Compared to adults aged 18-to-44 years, incidence rates of diagnosed diabetes in 2018 were higher among adults aged 45-to-64 years and those aged 65 years and older
- Prevalence of diagnosed diabetes was highest among American Indians/Alaska Native people (14.7%), people of Hispanic origin (12.5%), and non-Hispanic Black people (11.7%), followed by non-Hispanic Asians people (9.2%) and non-Hispanic white people (7.5%)

Chronic Disease: Quality of Life

Key Findings

In 2021, 23% of Perry County adults were limited in some way because of a physical, mental or emotional problem. The most limiting health problems were back or neck problems (71%); arthritis/rheumatism (40%); chronic pain (30%); walking problems (30%); and stress, depression, anxiety and emotional problems (24%).





- More than one-fourth (26%) of Perry County adults had fallen in the past year, increasing to 39% of those with incomes less than \$25,000.
- More than two-fifths (41%) of Perry adults who had fallen in the past year reported the fall caused an injury.
- Adults were responsible for providing regular care or assistance to the following: multiple children (25%); a friend, family member, or spouse who had a health problem (8%); elderly parent or loved one (8%); grandchildren (8%); an adult child (6%); someone with special needs (4%); a friend, family member or spouse with a mental health issue (3%); a friend, family member, or spouse with dementia (2%); children with discipline issues (2%); children whose parent(s) used drugs and were unable to care for their children (1%); and children whose parent(s) lost custody due to other reasons (1%).
- As a result of someone in their household having confusion or memory loss, adults reported someone in their household needed the most assistance in the following areas: safety (2%); transportation (1%); household activities (1%), and personal care (1%). Two percent (2%) of adults reported someone in their household did not need assistance in any area.

Social Conditions: Social Determinants of Health

Key Findings

In 2021, 8% of Perry County adults had to choose between paying bills and buying food. Eighteen percent (18%) of adults experienced four or more adverse childhood experiences (ACEs) in their lifetime (ACEs are stressful or traumatic events, for example, parents becoming separated or divorced, or living with someone who was a problem drinker or alcoholic).

Healthy People 2030

Social determinants of health (SDOH) are the conditions in the environments where people are born, live, learn, work, play, worship, and age that affect a wide range of health, functioning, and quality-of-life outcomes and risks. One of Healthy People 2030's 5 overarching goals is specifically related to SDOH: "Create social, physical, and economic environments that promote attaining the full potential for health and well-being for all."

- Healthy People 2030 developed five key determinants as a "place-based" organizing framework. These five determinants include:
 - Economic stability
 - Education Access and Quality
 - Health Care Access and Quality
 - Neighborhood and Built Environment
 - Social and Community Context

Social Determinants of Health





Economic Stability

- Adults reported the following percentage of their income goes to their housing:
 - Less than 30% (44%)
 - **—** 30-50% (33%)
 - 50% or higher (14%)
 - Don't know (8%)
- More than three-fourths (78%) of adults owned their home, 18% rented their home, and 4% reported another arrangement.
- In the past month, 3% of adults reported needing help meeting their general daily needs such as food, clothing, shelter, or paying utility bills, increasing to 30% of those with incomes less than \$25,000.

5% of Perry County adults, or approximately 1,305 adults experienced more than one food insecurity issue in the past year.

Perry County adults attempted to get assistance from the following social service agencies: Job & Family Services/JFS (16%), food pantries (6%), friend or family member (5%), WIC/health department (3%), Kno-Ho-Co Community Action Commission (2%), United Way (1%), place of worship (1%), other charities (1%), and somewhere else (2%). Two percent (2%) did not know where to look for assistance, and 5% did not qualify for assistance.

- Adults reported they or an immediate family member had the following literacy needs: learning computer skills (14%); reading and understanding instructions (7%); completing a job application (6%); and reading a map, signs, food ingredient labels, etc. (3%). Eighty-four percent (84%) of adults reported they or an immediate family member did not have any literacy needs.
- Adults experienced the following food insecurity issues during the past year: had to choose between paying bills and buying food (8%), food assistance was cut (6%), loss of income led to food insecurity issues (3%), worried food would run out (2%), and were hungry but did not eat because they did not have money for food (1%).
- Five percent (5%) of adults experienced more than one food insecurity issue.
- According to the 2019 American Community Survey 5-year Estimates, the median household income in Perry County was \$50,150. The U.S. Census Bureau reports median annual income levels of \$56,602 for Ohio and \$62,843 for the U.S. (Source: U.S. Census Bureau, 2019 American Community Survey 5-year Estimate).
- According to the 2019 Poverty and Median Household Income Estimates, 15.0% of all Perry County residents were living in poverty, and 20.6% of children and youth ages 0 to 17 were living in poverty (Source U.S. Census Bureau, Small Area Income and Poverty Estimates, 2019).
- The unemployment rate for Perry County was 6.6 as of February 2021 (Source: Bureau of Labor Statistics, Local Area Unemployment Statistics).
- According to the 2019 American Community Survey 5-year Estimates, in Perry County, there were 15,335 housing units. The owner-occupied housing unit rate was 88%. Rent in Perry County cost an average of \$646 per month (Source: U.S. Census Bureau, 2019 American Community Survey 5-year Estimate).



Estimated Poverty Rates in Ohio by County (2014-2018)



Social and Community Context

- Adverse childhood experiences (ACEs) are potentially traumatic events that occur in childhood, including experiencing violence, abuse, or neglect; witnessing violence in the home or community; and having a family member attempt or die by suicide. ACEs are linked to chronic health problems, mental illness, and substance use problems in adulthood. ACEs can also negatively impact education, job opportunities, and earning potential. (CDC, Preventing Adverse Childhood Experiences, Updated on April 6, 2021).
- Perry County adults experienced the following adverse childhood experiences (ACEs):
 - Their parents became separated or were divorced (21%)
 - Lived with someone who was a problem drinker or alcoholic (18%)
 - A parent or adult in their home swore at them, insulted them, or put them down (18%)
 - Lived with someone who was depressed, mentally ill, or suicidal (18%)
 - Someone at least five years older than them or an adult touched them sexually (13%)
 - Their parents or adults in their home slapped, hit, kicked, punched, or beat each other up (13%)
 - Lived with someone who used illegal stress drugs, or who abused prescription medications (12%)
 - Someone at least five years older than them or an adult tried to make them touch them sexually (8%)
 - Their family did not look out for each other, feel close to each other, or support each other (8%)
 - A parent or adult in their home hit, beat, kicked, or physically hurt them (7%)
 - Lived with someone who served time or was sentenced to serve time in prison, jail or correctional facility (7%)
 - Someone at least five years older than them or an adult forced them to have sex (3%)
 - They didn't have enough to eat, had to wear dirty clothing, and had no one to protect them (3%)
 - Their parents were not married (2%)
- Eighteen percent (18%) of Perry County adults experienced four or more adverse childhood experiences (ACEs).

The following graph shows the percentage of Perry County adults who experienced four or more adverse child experiences (ACEs) in their lifetime. Examples of how to interpret the information on the graph include: 18% of all Perry County adults had experienced four or more ACEs in their lifetime, including 23% of females and 18% of those with annual incomes less than \$25,000.

Adverse Childhood Experiences (ACEs)


- Adverse childhood experiences, or ACEs, are potentially traumatic events that occur in childhood (0-17 years), such as the following:
 - experiencing violence, abuse, or neglect
 - witnessing violence in the home or community
 - having a family member attempt or die by suicide
- Also included are aspects of the child's environment that can undermine their sense of safety, stability, and bonding such as growing up in a household with the following issues:
 - substance misuse
 - mental health problems
 - instability due to parental separation or household members being in jail or prison
- ACEs are linked to chronic health problems, mental illness, and substance misuse in adulthood. ACEs can also negatively impact education and job opportunities. However, ACEs can be prevented.
- ACEs are common. About 61% of adults surveyed across 25 states reported that they had experienced at least one type of ACE, and nearly 1-in-6 reported they had experienced four or more types of ACEs.
- Preventing ACEs could potentially reduce a large number of health conditions. For example, up to 1.9 million cases of heart disease and 21 million cases of depression could have been potentially avoided by preventing ACEs.
- Some children are at greater risk than others. Women and several racial/ethnic minority groups were at greater risk for having experienced 4 or more types of ACEs.
- ACEs are costly. The economic and social costs to families, communities, and society totals hundreds of billions of dollars each year.
- ACEs can have lasting, negative effects on health, well-being, and opportunity. These experiences can increase the risks of injury, sexually transmitted infections, maternal and child health problems, teen pregnancy, involvement in sex trafficking, and a wide range of chronic diseases and leading causes of death such as cancer, diabetes, heart disease, and suicide.

Neighborhood and Built Environment

Just over one-fourth (26%) of Perry County adults reported that their neighborhood was extremely safe; 54% reported it to be quite safe, 16% reported it to be slightly safe, and 1% reported it to be not safe at all. Three percent (3%) reported that they did not know how safe from crime their neighborhood was.

Examples of how to interpret the information include: 26% of all Perry County adults described their neighborhood as extremely safe, including 28% of males and 20% of those with annual incomes less than \$25,000.



- Eleven percent (11%) of Perry County adults reported the following transportation issues: other car issues/expenses (5%), suspended/no driver's license (3%), could not afford gas (3%), disabled (3%), no car (2%), limited public transportation available or accessible (2%), did not feel safe to drive (2%), no public transportation available or accessible (2%), cost of public or private transportation (1%), and no car insurance (1%). Thirty-eight percent (38%) of adults who reported having transportation issues had more than one issue.
- Perry County adults indicated they use the following forms of transportation regularly: their own vehicle or family vehicle (96%), ride from a friend or family member (8%), walking (8%), public transportation (1%), bike (1%), and other (1%).
- Perry County adults reported doing the following while driving in the past month: talking on hand-held cell phone (48%); talking on hands-free cell phone (45%); eating (43%); texting (28%); not wearing a seatbelt (20%); using Internet on their cell phone (15%); being under the influence of alcohol (5%); reading (3%); being under the influence of recreational drugs (2%); being under the influence of prescription drugs (1%); and other activities (such as applying makeup, shaving, etc.) (1%). Fifty-eight percent (58%) of adults had more than one distraction. Four percent (4%) of adults reported they did not drive.

- Perry County adults reported they would support the following community improvement initiatives: more locally grown foods or farmer's markets (67%), safe roadways (59%), new/updated parks (52%), neighborhood safety (49%), bike/walking trail accessibility and connectivity (46%), local agencies partnering with grocery stores to provide healthier low-cost food items (45%), new/updated recreation centers (40%), sidewalk accessibility (38%), and community gardens (37%). Eleven percent (11%) of adults reported they would not support any of the community improvement initiatives.
- Two-thirds (67%) of Perry County adults kept a firearm in or around their home. Nine percent (9%) of adults reported that their firearms were unlocked and loaded.
- Adults with firearms in or around their home reported the following reasons for having them: protection (76%), hunting or sport (72%), work (6%), and other reasons (14%).

The following graph shows the percentage of Perry County adults that have a firearm in or around the home. Examples of how to interpret the information include: 67% of all Perry County adults had a firearm in or around the home, including 67% of males and 71% of those with annual incomes of \$25,000 or more.

Victims of Gun Violence in America

- Every year, 115,551 people are shot in murders, assaults, suicides & suicide attempts, accidents or by police intervention in America in an average year.
 - 38,826 people die from gun violence and 76,725 people survive gun injuries.
- Every day, an average of 316 persons are shot in America. Of those 316 people, 106 people die and 210 are shot, but survive.
 - Of the 310 people who are shot every day, an average of 22 are children and teens.
 - Of the 103 people who die, 64 are suicides, one death is unintentional, one is by legal intervention, and one with an unknown intent.
 - Of the 210 people who are shot but survive, 95 are assaulted, 90 are shot accidently, ten are suicide attempts, four are legal interventions and 12 are shot with an unknown intent.

Social Conditions: Environmental Conditions

Key Findings

Perry County adults reported the following as the top three issues that threatened their health in the past year: insects (11%), rodents (11%), and mold (8%). Seventeen percent (17%) of adults felt their household was well prepared to handle a large-scale disaster or emergency.

11% of Perry County adults, or approximately 2,871 adults reported that insects and rodents threatened their or their family members' health in the past year.

Environmental Health

- Perry County adults thought the following threatened their or their family members' health in the past year:
 - Insects (11%)
 - Rodents (11%)
 - Mold (8%)
 - Moisture issues (6%)
 - Temperature regulation (heating and air conditioning) (6%)
 - Air quality (4%)
 - Unsafe water supply/wells (4%)
 - Plumbing problems (3%)
 - Sewage/wastewater problems (3%)

- Agricultural chemicals (2%)
- Asbestos (2%)
- Bed bugs (2%)
- Chemicals found in household products
- Safety hazards (structural problems) (2%)
- Sanitation issues (1%)
- Radon (1%)
- Lead paint (1%)
- Eighteen percent (18%) of Perry County adults reported more than one environmental issue that threatened their or their family members' health in the past year.
- More than two-thirds (69%) of adults used a septic tank for wastewater. Of those who used a septic tank, 41% reported it was pumped within the past 5 years. More than one-fifth (22%) have never had their septic tank pumped, and 23% did not know the last time it was pumped.

Mold Prevention Tips

- Exposure to damp and moldy environments may cause a variety of health effects. Some people are sensitive to molds. For these people, exposure to molds can lead to symptoms such as stuffy nose, wheezing, and red or itchy eyes, or skin. Some people, such as those with allergies to molds or with asthma, may have more intense reactions.
- In your home, you can control mold growth by:
 - Keeping humidity levels as low as you can, no higher than 50%, all day long.
 - Making sure your home has enough ventilation. Use exhaust fans which vent outside your home in the kitchen and bathroom. Make sure your clothes dryer vents outside your home.
 - Fixing any leaks in your home's roof, walls, or plumbing so mold does not have moisture to grow.
 - Not using carpet in rooms or areas like bathrooms or basements that may have a lot of moisture.

Disaster Preparedness

- Perry County households had the following disaster preparedness supplies: cell phone (89%), cell phone with texting (89%), working flashlight and working batteries (83%), working smoke detector (82%), computer/tablet (79%), reliable internet (65%), three-day supply of nonperishable food for everyone in the household (61%), three-day supply of prescription medication for each person who takes prescribed medicines (60%), three-day supply of water for everyone in the household (one gallon of water per person per day) (51%), working battery-operated radio and working batteries (47%), generator (44%), home land-line telephone (32%), communication plan (24%), and a family disaster plan (8%).
- Ninety-seven percent (97%) of Perry County adults reported having more than one disaster preparedness supply. Three percent (3%) reported having none of the above disaster preparedness supplies.
- Seventeen percent (17%) of adults felt their household was well prepared to handle a large-scale disaster or emergency. Sixty-one percent (61%) reported their household was somewhat prepared, 19% reported not prepared at all, and 4% did not know.
- In a large-scale disaster or emergency, adults reported the following methods or ways of getting information from authorities: Internet (72%), friends/family (72%), television (70%), radio (65%), wireless emergency alerts (53%), emergency alert system (51%), Facebook (51%), neighbors (49%), text message (45%), smart phone app (32%), landline phone (15%), newspaper (14%), other social media (10%), Twitter (9%), and other ways (2%).

Social Conditions: Parenting

Key Findings

In the past year, 80% of adults talked to their child ages 12-to-17-year-old about a career plan/post-secondary education, weight status, and social media issues. Eighty-six percent (86%) of parents took their child to a doctor/health care provider for regular check-ups.

Parenting

In the past year, parents reported taking their child (ages 17 or younger) to the doctor/health care provider for: regular checkups (86%), routine vaccinations (84%), dental visits (79%), other visits (for any illness) (41%), ear infection (18%), injuries (14%), behavioral problems (11%), and asthma (5%).

Perry County parents indicated that their child rode in a car seat, booster seat, or wore a seatbelt at the following frequencies:

In the past year, adults talked to their child ages 12-to-17-year-old about the following topics: career plan/post-secondary education (80%); weight status (eating habits, physical activity, and screen time) (80%); social media issues (80%); dating and relationships (75%); energy drinks (45%); body image (40%); negative effects of alcohol, tobacco, illegal drugs or misusing prescription drugs (35%); abstinence and how to refuse sex (25%); school/legal consequences of using alcohol tobacco or other drugs (25%); bullying (cyber, indirect, physical, verbal) (20%); refusal skills/peer pressure (20%); depression, anxiety, suicide (15%); volunteering (15%); and birth control, condoms, safer sex, STD prevention (15%). Five percent (5%) of parents reported they did not talk about any of the above topics to their child.

Ohio Child Passenger Safety

The American Academy of Pediatrics (AAP) and the National Highway Transportation Safety Administration recommend parents use the following four steps to keep their children safe.

Step 1: Rear-Facing Car Seat – placed in the back seat -- The AAP recommends that children ride in a rearfacing seat until they reach the upper height and weight limits of their seat or until they're 2 years old. Ohio law requires that young children be properly restrained in a car seat.

Step 2: Forward-Facing Car Seat – placed in the back seat -- Once children outgrow their rear-facing seat, Ohio law requires that children less than 4 years old and 40 pounds be properly secured in a car seat.

Step 3: Booster Seat – placed in the back seat -- Once children reach the upper limit of their forward-facing car seat, Ohio law requires that children ride in a booster seat until they are at least 4'9" tall or 8 years old.

Step 4: Adult Seat Belt – in the back seat until at least 13 years old -- Children who have outgrown their booster seats should ride in the back seat until they're at least 13 years old. Ohio law requires children aged 8-15 years, who are not secured in a car seat or booster seat, to be secured by the vehicle seat belt.

Appendix III: Methods for Weighting the 2021 Perry County Health Assessment Data

Data from sample surveys have the potential for bias if there are different rates of response for different segments of the population. In other words, some subgroups of the population may be more represented in the completed surveys than they are in the population from which those surveys are sampled. If a sample has 25% of its respondents being male and 75% being female, then the sample is biased towards the views of females (if females respond differently than males). This same phenomenon holds true for any possible characteristic that may alter how an individual responds to the survey items.

In some cases, the procedures of the survey methods may purposefully over-sample a segment of the population in order to gain an appropriate number of responses from that subgroup for appropriate data analysis when investigating them separately (this is often done for minority groups). Whether the over-sampling is done inadvertently or purposefully, the data needs to be weighted so that the proportioned characteristics of the sample accurately reflect the proportioned characteristics of the population. In the 2021 Perry County survey, a weighting was applied prior to the analysis that weighted the survey respondents to reflect the actual distribution of Perry County based on age, sex, race, and income.

Weightings were created for each category within sex (male, female), race/ethnicity (white, non-white), Age (8 different age categories), and income (7 different income categories). The numerical value of the weight for each category was calculated by taking the percent of Perry County within the specific category and dividing that by the percent of the sample within that same specific category. Using sex as an example, the following represents the data from the 2021 Perry County Survey and the 2019 Census estimates.

In this example, it shows that there was a slightly smaller portion of males in the sample compared to the actual portion in Perry County. The weighting for males was calculated by taking the percent of males in Perry County (based on Census information) (49.97224%) and dividing that by the percent found in the 2021 Perry County sample (46.92737%) [49.97224 / 46.92737 = weighting of 1.064885 for males]. The same was done for females [50.02776 / 53.07263 = weighting of 0.942628 for females]. Thus, males' responses are weighted more by a factor of 1.064885 and females' responses weighted less by a factor of 0.942628.

This same thing was done for each of the 19 specific categories as described above. For example, a respondent who was female, Black, in the age category 35-44, and with a household income in the \$50-\$75k category would have an individual weighting of 0.95150 [0.94263 (weight for females) x 0.60723 (weight for non-white) x 1.69428 (weight for age 35-44) x 0.98114 (weight for income \$50-\$75k)]. Thus, each individual in the 2021 Perry County sample has their own individual weighting based on their combination of age, race/ethnicity, sex, and income. See next page for each specific weighting and the numbers from which they were calculated.

Multiple sets of weightings were created and used in the statistical software package (SPSS 26.0) when calculating frequencies. For analyses done for the entire sample and analyses done based on subgroups other than age, race, sex, or income – the weightings that were calculated based on the product of the four weighting variables (age, race, sex, income) for each individual. When analyses were done comparing groups within one of the four weighting variables (e.g., smoking status by race/ethnicity), that specific variable was not used in the weighting score that was applied in the software package. In the example smoking status by race, the weighting score that was applied during analysis included only age, sex, and income. Thus, a total of eight weighting scores for each individual were created and applied depending on the analysis conducted. The weight categories were as follows:

- 1. **Total weight** (product of 4 weights) for all analyses that did not separate age, race, sex, or income.
- Weight without sex (product of age, race, and income weights) used when analyzing by sex.
- 3. **Weight without age** (product of sex, race, and income weights) used when analyzing by age.
- 4. Weight without race (product of age, sex, and income weights) used when analyzing by race.
- Weight without income (product of age, race, and sex weights) used when analyzing by income.
- Weight without sex or age (product of race and income weights) used when analyzing by sex and age.
- Weight without sex or race (product of age and income weights) used when analyzing by sex and race. 7.
- 8. **Weight without sex or income** (product of age and race weights) used when analyzing by sex and income.
